## Gen L. F. Chapman, Jr. Named Commandant

A WWII artillery officer who has kept pace with the expanding technology of waging war, particularly in the field of automation, is the 24th Commandant of the Marine Corps.

Gen Leonard F. Chapman, Jr. moves into the Corps top management billet and a seat on the Joint Chiefs of Staff from the post of Assistant CMC. He was Gen Wallace M. Greene, Jr.'s Chief of Staff for 3½ years and was the motivating force behind the Corps' front-running position in automated military management. His views on the subject and its application to Marine Corps operations appeared in the October 67 issue of the GAZETTE.

Congress confirmed the President's nomination without pause for the traditional four-year term (unique among the four services). Senator Mike Mansfield, a former Marine, said the President made "the best possible choice which time will prove wise."

Senator Thurmond expressed his confidence that "he will make one of the finest Commandants the Marine Corps has ever had."

Senator Smathers noted that he and the new CMC attended the same school at the same time: the University of Florida.

The new Commandant was the recipient of the Armed Forces Management Association Merit Award in 1967 for "outstanding accomplishment in professional management."

Named to Assistant CMC was LtGen Lewis W. Walt. His successor as Deputy ColS for Manpower has not been named.

Gen Greene who leaves the Corps after 37 years service received the Distinguished Service Medal from President Johnson prior to his retirement.

## Grace Period For Insurance

Servicemen now being discharged from active duty have the protection of their National Servicemen's Group Life Insurance policies extended for 180 days at no cost to them. During that period they are entitled to apply for and receive their private life insurance at regular rates, regardless of any disabilities they have incurred in the service. They may apply to any of more than 500 commercial insurance companies which participate in the program.



## Retroactive Pay Raise

The 5.6% military pay raise bill, retroactive to 1 Oct, was signed into law by President Johnson on 16 Dec 1967 in time for the "bonus" to be distributed prior to Christmas.

Anticipating the formal approval, SecNav authorized Naval Service disbursing offices to prepare to distribute the checks before the actual signing, enabling them to make the distribution immediately following the official approval.

Sen W. Morse (D-Oreg.) commented on the raise, indicating he felt that even with the raise the military was underpaid.
